  - The Board discussed the challenges faced in reaching the committee's goal of reducing the average increase in the household tax levy from \$282 to \$200. The Leadership Team and the Finance Committee were able to reduce the level to \$206.63.
  - The Leadership Team will continue to monitor several areas that may result in additional savings. Short of finding additional savings in those areas, the Board was polled to determine if reducing to the \$200 level was required or whether the current level was sufficient. By a 7-1 vote, it was agreed to proceed with the reduced budget and continue to explore options up until the public hearing on April 27<sup>th</sup>.
