**WHEREAS**, this pending legislation, S2663, has already been adopted by the Senate.

# **NOW THEREFORE, BE IT RESOLVED, That:**

- 1) The Legislature is urged to adopt A4234;
- 2) A copy of this resolution shall be transmitted to the Assembly Speaker and the Legislative Delegation in the district, as well as the Governor and the Commissioners of the Department of Banking and Insurance and the Department of Community Affairs.
