As subsequent work to these meetings, I'm currently reflecting on the budget asks and holding them up against our district goals as a way of eventually prioritizing in the upcoming weeks in order to make fiscally responsible decisions that still prioritize the enhanced achievement we are working on over time to actualize.

Our winter sports season is well underway. Please check out our social media outlets for regular updates. An early highlight centers on the boys' basketball team, which won the Hopatcong Holiday Tournament.
